


Supply and use of VMP in Beekeeping
The cases of France



Who can deliver VMP in FRANCE



Health groups or GDSA "Groupement de défense Sanitaire Apicole":

- Are local non governmental organizations (scope: departments or regions)
- Are accredited by the administration
- Contribute to the beekeeping sector
- Perform livestock health supervision
- Make VMP available to beekeepers: ordering, stock management and distribution under certains conditions



Health groups can distribute VMP: livestock health programs *PSE - Programme Sanitaire d'Elevage*

Regulated by law, so some constraints - A detailed case file must be submitted to the administration, this file must describe:

- Who will be responsible for dispensing VMP, must be a veterinarian or a pharmacist
- The disease against which the group wants to fight. **Only Varroa** for beekeepers.
- The list of VMP and their specialty name that the group intends to distribute and how they will do that.
- Who will keep the stock of VMP
- How and when VMP should be used
- → Agreements are valid for 5 years and 100% of beekeepers in the group shall be inspected in this span of time

Health groups can distribute VMP

Also, real benefits for beekeepers

- Costs of VMP for beekeepers due to the economies of scale
- Advice from either Veterinarians or Technicians (TSA Techniciens Sanitaires
 Apicoles) during regulatory visits:
 - Support and training to beekeepers about Bee Health
 - How to use VMP and how to have better beekeeping practices
 - Possibly visits colonies to detect disease and collect samples (bees, brood...)
 - Check that beekeepers comply with regulations (annual declaration of apiaries, keeping of breeding register)



Some figures

Cost for the Group (GDSA):

- Veterinarian or pharmacist responsible: 1000/5000 € per year
- Visits of beekeepers by Technicians and/or veterinarian mostly travel expense on short distances - around 1 000 technicians, mostly volunteers.

Cost for beekeepers:

- Membership fee: Some difference between department, but generally cheap for backyard beekeepers, less than 50 euros per year/ between 100 and 200 € for professional beekeepers (say, 400 hives)
- Between 15 at 30% discount on MVP.

A few stats (2022, extrapolation from data available for 40 groups):

Apivar:130K / Apitraz: 40K / Formicpro-2: 40K / Apistan: 16K / Varromed: 10K

Role of Fnosad a Federation of Departmental Health Organization

Fédération Nationale des Organisations Sanitaires Apicoles Départementales

Fnosad is a Non-profit/non-governmental organization aiming at federating local beekeeping health organization:

- → In 2023, 80 departments (out of 96) are members which represents more than 36 000 beekeepers (out of 63 000 known beekeepers)
- Carry out studies to monitor the effectiveness of treatments and resistance studies.
- Support departmental bee health organization in completing the livestock health program.
- Provide groups with a software in order to manage members, billing, VMP ordering & distribution

 40 departmental organizations use this tool
 Publish and distribute reference manual (e.g. Varroa) for a small fee
